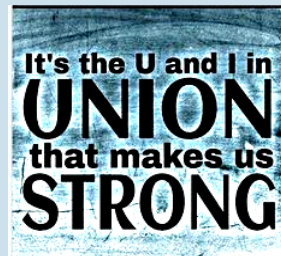
### A Year in Closing
